Criteria: Must be at least 21 years of age upon date of hire 4-year Bachelor's Degree (any major) OR Associate's Degree AND three years of Law Enforcement experience (single agency) OR Military service (Active, Reserve, or National Guard), currently serving or honorably discharged, with one or more of the following medals: Afghanistan Campaign Medal, Iraq Campaign Medal, Global War on Terrorism Expeditionary Medal, Southwest Asia Service Medal, Kosovo Campaign Medal, Korean Defense Service Medal The hiring process will consist of: Application Submission (CMS 100) Physical Fitness and Swimming Proficiency Tests In-person Interview Psychological Examination Medical Examination Background Investigation

Unless previously certified as a Police Officer in Illinois, selected applicants will be required to complete a paid, 14-week police certification at the Illinois State Police Academy. An additional paid, 14-week Conservation Academy must be completed as a condition of employment. During these training academies, selected applicants will be provided meals and lodging on-site, Monday-Friday.
